

URGENT: cryoICE RECALL NOTIFICATION DUE TO POTENTIAL STERILITY BREACH

This is to inform you of a product recall (aka Field Safety Notice) involving:

AtriCure cryolCE cryo-ablation probe (CRYO2); Lot numbers 26500 through 53607

See product label below.



This recall has been initiated due to a packaging defect that could potentially compromise the sterility of this device. Use of a non-sterile device could potentially cause permanent impairment or life-threatening injury. Immediately examine your inventory, quarantine any affected product subject to this recall, and return to AtriCure. As of November 21, 2014, no injuries, impairments, or deaths have been reported.
