Summary of risk management plan for Metoprolol Medical Valley prolongedrelease tablet (Metoprolol succinate)

This is a summary of the risk management plan (RMP) for Metoprolol Medical Valley prolonged-release tablet. The RMP details important risks of Metoprolol Medical Valley prolonged-release tablet, how these risks can be minimised, and how more information will be obtained about Metoprolol Medical Valley prolonged-release tablet 's risks and uncertainties (missing information).

Metoprolol Medical Valley prolonged-release tablet 's summary of product characteristics (SmPC) and its package leaflet give essential information to healthcare professionals and patients on how Metoprolol Medical Valley prolonged-release tablet should be used.

Important new concerns or changes to the current ones will be included in updates of Metoprolol Medical Valley prolonged-release tablet 's RMP.

I. The medicine and what it is used for

Metoprolol Medical Valley prolonged-release tablet is authorised for:

Adults:

- Hypertension
- · Angina pectoris
- Hyperkinetic heart syndrome
- Tachyarrhythmias
- Long-term treatment following myocardial infarction
- · Migraine prophylaxis
- Stable, chronic, mild to moderate heart failure with impaired systolic ventricular function (ejection fraction ≤40%) – as an add-on to the usual standard treatment with ACE inhibitors and diuretics and, if necessary, cardiac glycosides

Children from 6 years of age and adolescents:

Hypertension (see SmPC for the full indication).

It contains Metoprolol as the active substance and it is given by oral route.

II. Risks associated with the medicine and activities to minimise or further characterise the risks

Important risks of Metoprolol Medical Valley prolonged-release tablet, together with measures to minimise such risks, are outlined below.

Measures to minimise the risks identified for medicinal products can be:

- Specific Information, such as warnings, precautions, and advice on correct use, in the package leaflet and SmPC addressed to patients and healthcare professionals;
- · Important advice on the medicine's packaging;
- The authorised pack size the amount of medicine in a pack is chosen so to ensure that the medicine is used correctly;
- The medicine's legal status the way a medicine is supplied to the patient (e.g. with or without prescription) can help to minimise its risks.

Together, these measures constitute routine risk minimisation measures.

In addition to these measures, information about adverse reactions is collected continuously and regularly analysed, so that immediate action can be taken as necessary. These measures constitute routine pharmacovigilance activities.

II.A. List of important risks and missing information

Important risks of Metoprolol Medical Valley prolonged-release tablet are risks that need special risk management activities to further investigate or minimise the risk, so that the medicinal product can be safely taken. Important risks can be regarded as identified or potential. Identified risks are concerns for which there is sufficient proof of a link with the use of Metoprolol Medical Valley prolonged-release tablet. Potential risks are concerns for which an association with the use of this medicine is possible based on available data, but this association has not been established yet and needs further evaluation. Missing information refers to information on the safety of the medicinal product that is currently missing and needs to be collected (e.g. on the long-term use of the medicine).
