Madam, Sir,

Newdeal SAS has become aware of incidents regarding the breakage of some <u>drilling</u> guides for diameter 3.5 mm screw (reference : 219 635).

The drilling guides for diameter 3.5mm screw (reference 219 635) are instruments included in the following Newdeal instrumentation sets:

- TIBIAXYS® Ankle Arthrodesis Plating System
- TIBIAXYS® Distal Tibia and Fibula Osteotomy Plating Systems
- ADVANSYS® Dorsal Lisfranc Plate / ADVANSYS® Medial Lisfranc Plate
- Uni-CP™ Compression plating system

Although most of the incidents occurred during Tibiaxys® surgeries, as a preventive measure, Newdeal SAS has made a decision to conduct a recall of the drilling guides included in the 4 above listed instrumentation sets.

Since March 2011, Newdeal has marketed a new version of the drilling guide, the reference remaining the same (219 635). Only « the old version » of the drilling guide is concerned by this recall.

In order to help you to identify the affected device (old version) please refer to the enclosed *Appendix - instruction sheet*.

We are notifying you of the recall as our records indicate that you have been supplied with some of these drilling guides.

Those ones may have been shipped either in an instrumentation set or individually packed.




