Mobilett Mira: risk of lost images during examination

Dear customer,

This letter is to inform you of a potential hazard to patients when using the Mobilett Mira.

When does this malfunction occur and what are the potential risks?

When the imaging system of Mobilett Mira (i.e. the computer with touch screen) is running for a long period of time without interruption, it might occur in rare cases that images are not stored correctly despite the fact that X-ray was released. In this case the imaging system would have to be restarted and the examination would have to be repeated, leading to increased examination time and additional radiation dose for the patient.

What steps can the user take to avoid the potential risk?

- As the probability of the described problem increases over time, the operator(s) should make sure
 that the imaging system of Mobilett Mira is shut down or restarted whenever Mira is not being used,
 but latest after 10 hours of continuous uptime. This is performed by switching off the Mobilett Mira
 with the key.
- On request, a service technician from Siemens can deactivate the software component which causes
 the error. This makes the previous advice to frequently restart the system unnecessary, but will result

How will the issue finally be resolved?

Siemens is preparing a modification of Mobilett Mira which will resolve this potential malfunction permanently. The field modification (Update Instruction XP054/12/S) will be released in October 2012, and your system will be updated free of charge by a Siemens Service technician.

We ask you to immediately instruct your personnel accordingly. Please ensure that this field safety notice is placed in the System's instructions for use. Your personnel should maintain awareness until the final solution is available.

If you have sold your Mobilett Mira and/or it is no longer in your possession, we kindly ask that you forward this field safety notice to the new user of the Mobilett Mira. Please inform us about the new owner of the Mobilett Mira.

We apologize for the issue and any inconvenience it might have caused.
