Urgent: Field Safety Notice / 002-13

Dear Distributors / Subsidiaries,

This letter contains important information that requires your immediate attention.

Please note this notice has been communicated to the appropriate European Regulatory Agency.

Please note that you are not concerned by this information if your customers work with the second reading function activated for all the test results.

Description of the problem:

Further to customer complaints, we have been made aware that in some specific conditions, inconsistent grading between the results in the well/card and the results returned by the IH-1000 may be observed.

After deep investigations, we have been able to confirm that in these very specific conditions, positive reactions might be read as negative by the system due to the analysis algorithm of the images.

Therefore, this issue might lead to a wrong result released to the host if all the 3 following conditions are met:

- 1. A result is returned as negative while the reaction is positive, DP, or requires a human interpretation and,
- 2. This negative result is consistent with the global interpretation of the test and,
- 3. The system is configured without the second reading function activated for all tests results.

Impact on the patient:

The probability of the occurrence of such cases is remote. However, considering that the described issue might affect the patient test results, we are informing you so that you can take the appropriate protective measures.

Immediate protective measure:

To exclude the residual risk, we advise you to immediately implement the following protective measures:

- 1. Log in as "Administrator".
- 2. In the toolbar click on "Configuration", then, choose "Common".




Illustration of IH-Com selection "second reading" function

before the sending to the host.

Please note there is no way to select only the negative results.




Illustration of IH-Com "second reading" function

4. Check the consistency between the result in the well/card and the result returned by the system.

Long term corrective action:

This issue will be permanently corrected in the next IH-1000 software patch. The patch will be available in the **end of August**.
