

URGENT FIELD SAFETY NOTICE

June 18, 2013

Re: Innovacon Multi-Drug Multi-Line Twist Screen Test Device Saliva Collector

Dear Valued Customer:

Innovacon, Inc. is issuing a Field Safety Notice for the Saliva Collector that is an accessory in the Innovacon Multi-Drug Multi-Line Twist Screen Test Device. In certain lots, the sponge may become dislodged from the Saliva Collector handle prior to or during the oral fluid sample collection process. If the sponge becomes dislodged during the specimen collection process, the donor may inadvertently swallow the sponge which could present a choking risk. Our investigation indicates that the sponge may become dislodged on approximately 5% of the Saliva Collectors from affected lots.

Saliva Collector Inspection Process:

Before using the Saliva Collectors for the lots specified below, gently pull the sponge while it is in the wrapper to ensure it remains firmly attached to the handle. Immediately discard any Saliva Collectors if the sponge detaches from the handle. Alternatively, contact your sales representative at Innovacon to receive replacement product.

The attached tables show the affected products and lot numbers.

CUSTOMER REQUIRED ACTIONS

- Immediately implement the recommended inspection step of gently pulling the sponge before using the Saliva Collector.
- Discard all Saliva Collectors where the sponge detaches from the handle after gently pulling
 it.
- If you prefer to receive replacement product, rather than performing the inspection step above, please contact your sales representative at Innovacon.
- Complete and FAX the enclosed Verification Form within 10 days to confirm your receipt of this notice. (Please return the form even if you have no remaining inventory or do not have any involved product in order to confirm receipt of this notification).
- Please ensure that all users of the device have received a copy of this Urgent Field Safety Notice
