The ceiling mount supplier encountered an event in which the drive screw in the motor unit, which lifts and lowers the lower lift arm, broke. As a result, the lift arm fell down approx. 60 cm (23.6 inches). Leica Microsystems has currently not received any reported cases, however, as a preventative measure Leica Microsystems plans to perform a field correction of all microscope systems affected by this potential failure mode

Further review has determined that the potential failure can be detected by performing a visual inspection. Additionally, if maintenance has been performed according to manufacturers' recommendations there is remote risk that a failure will be experienced.

Your Leica Microsystems representative will contact you to make the necessary arrangements to complete the inspection of the ceiling mount, per manufacturer's recommendations and to provide additional Preventative Maintenance and Inspection protocols for these devices.
