Important safety notice

Inspection of our ML 301 examination lamp – danger to patients and users

Dear customer and user,

as part of our worldwide product surveillance and following a safety notice from our supplier Ondal Medical Systems GmbH, it is our duty to inform you of risks to patients and users that may arise in the use of certain Gebrüder Martin GmbH & Co. KG products which feature the Ondal Acrobat[®] Swing spring arm.

Our supplier Ondal Medical Systems GmbH reports that after an average usage period of seven years fatigue failure of the plastic joint may occur. The manufacturer has become aware that a joint on the spring arm may break either during use or when the spring arm is not in operation. If the joint breaks, the spring arm falls suddenly and without hindrance. In such a case there is a high risk of injury to the patient and other persons in the immediate vicinity.

Safety and procedural instructions, corrective action

In order to preclude unnecessary risks, Gebrüder Martin must ask you to carry out an inspection of all the Ondal Acrobat[®] Swing spring arms which have been delivered to you. Kindly inspect the units that have been delivered to you by Gebrüder Martin.

You will find a list of the products which have been delivered to you and may potentially be affected in Attachment 1.

If inspection in accordance with Attachment 2 reveals that an aluminium joint was used, there is nothing to be said against continuing to use the examination lamp.

Please make sure that your customers ('customers' refers only to specialist trade partners), users and / or any staff whom this may concern are informed of this safety notice and the instructions it contains.

We offer to replace the spring arm or arms concerned at a price of 140,- euros net plus VAT. Neither the costs of installation and removal nor those of further consequential loss or damage caused thereby are covered by this offer.

We are sorry for the inconvenience caused. The measures described here are of a preventive nature and aim to ensure the safety of patients and users.

Please retain this notice for at least as long as it takes to complete the measures.
