## Field Safety Corrective Action: Recall of medical products

Joline Short term/Acut-Dialysis-Catheter (Catalog Nr. in

Annex), Production date period 06/2012 - 02/2013

### Problem description:

During the usage of the Joline Acute Dialysis catheters of the production period from **06/2012** – **02/2013** sporadically hairline cracks occurred in the connectors of the catheters. This may occur more frequently if highly alcoholic disinfectants are used.

The reason for the hairline cracks was identified and eliminated.

## Advisory Notice for the operator or customer:

- Stop the sale of affected products of the specified manufacturing period.
- Take any necessary action to address all your customers and ask them to stop the use of the products affected by this recall.
- Check your stock and put all affected products under quarantine.
- If you have delivered products affected by this recall, to your customers, please make sure to inform them about the recall and arrange that they initiate their recall routine.
- Please assure that this information is forwarded to all qualified personnel to which affected products were delivered.
- Fill in the table of the return record (attached) and send it to your responsible distributor.
- Your responsible distributor will get in touch with you to organize all necessary steps for the return of the affected products.



# Risk for the patient:

There was no endangerment to patients when connector cracks occurred so far. But it can't be excluded that there might be blood loss.

There is no additional aftercare for patients necessary.
