In March 2013, DePuy Orthopaedics, Inc. issued a voluntary device correction for the RECLAIM® Distal Reamer Extension (2975-00-500) due to the potential for one or both of the tabs on the original design to break off and potentially be left in the patient. The RECLAIM® Distal Reamer Extension has been redesigned, and the company is formally swapping out the affected instruments.

Swap-Out Instrument Set

The redesigned instruments include a RECLAIM Clear-Out Reamer (2976-20-000) and an updated RECLAIM Instrument Tray (2975-50-600), which will be included as part of the swap-out set.





Figure 2: Redesigned RECLAIM® Instrument Tray (2975-50-600) – Note: The swap-out set will contain: 1 #2975-50-600 (empty), 2 #2975-00-500 (redesigned distal reamer extensions), and 1 #2976-20-000 (clear out reamer)

The swap-out set will consist of (see Figure 2):

The figure below highlights the redesigned swap-out distal reamer extension instruments, tray, and clear-out reamer compared with the affected instruments and tray:






Figure 4: Visual Comparison Between the Redesigned Instrument and Tray and the Affected Instrument and Tray. NOTE: The part number is the same for the Affected & the Redesigned Distal Reamer Extensions (2975-00-500)

Summary of the February 25, 2013 Correction Notice:

In March, 2013, DePuy Orthopaedics, Inc. issued a device correction for all lots of the RECLAIM Distal Reamer Extensions due to the potential for one or both of the tabs to break off and potentially be left in the patient.

Intended Use

The RECLAIM Modular Revision Hip System is used to reconstruct the hip joint in moderate to complex revisions. The RECLAIM Distal Reamer Extension attaches to the RECLAIM Reamers to lengthen the instrument for improved ease of use during preparation of the femur for implantation of the RECLAIM Distal Stem.

Reason for Device Correction and Swap-Out

Prior to the instrument's redesign, DePuy Orthopaedics, Inc. identified the potential for the RECLAIM Distal Reamer Extension tabs to break off. DePuy has received 9 complaints reporting tab breakage since 2011. None of the complaints have indicated fragments were left in patients. Since the device correction, there have been 37 additional complaints regarding the tabs breaking. Also,



after investigating it was determined that one of the original complaints was not tab-related. There are a total of 45 tab-related complaints.

Clinical Implications of Affected Instruments

- In remote circumstances, the possible clinical implications related to RECLAIM Distal Reamer Extension tabs that break off and are left in the patient may include:
 - Significant surgical delay due to attempted retrieval of remaining fragments
 - Serious surgical delay due to both reamer extensions having broken tabs and where another system may need to be brought in to complete the surgery.
 - Adverse tissue reaction
 - o Pain due to potential bone remodeling or during magnetic resonance imaging (MRI)
 - o Poor joint mechanics if the remaining fragment is left in the joint space
