# **Description of the problem:**

Cook Medical has received a small number of reports related to the inability to spray the powder for the Hemospray Endoscopic Hemostat. These reports involve difficulty spraying the Hemospray powder from the delivery system. Adverse events that may occur due to spraying difficulties include inadequate treatment.

### Advise on action to be taken by the user:

- Please review the attached customer list and quarantine any affected product that remains in your stock.
- 2. Immediately collect all remaining unused products. The remaining unused products should be returned as soon as possible via DHL quoting Cook Medical's account number: 952049139 to arrange pick up.
