Dear Customer,

This letter contains important information that requires your immediate attention.

BioRad/DiaMed GmbH is voluntarily recalling the product identified above. This recall is being conducted as a precautionary measure due to a product contamination.

Please note that the relevant European Regulatory Agency has been advised of this FSCA.

Description of the problem:

In the context of an internal investigation, we were able to demonstrate that the well number 3 of some of the ID cards *NaCl, Enzyme Test and Cold Agglutinins* of the above lot may contain, on a random basis, a very small amount of monoclonal anti-E (anti-RH3).

Impact on the patient:

This issue might have led to unexpected results for tests carried out where the cell used in position 3 was E+ (RH:3):

- Reverse group with the group O cell
- Antibody screening with ID-Diacell if carried out in saline or enzyme with the following cells: I-II-III Asia, ID-DiaScreen Prophylax, ID-Diacell I-II-Dia+, ID-Dia+, ID-SF.
- Identification Panel, ID-Panel Plus 6 tested in enzyme or in saline
- Enzyme crossmatch.

Considering the usual practices in the laboratories, the residual patient risk is extremely low as these results should have led to additional tests.

Immediate protective measure:

In light of this information, we advise the users of this lot of ID cards to use another lot if available in the laboratory and destroy the remaining stock of lot 50520.93.09. This lot will be replaced free of charge.

Note: If no other lot is immediately available and if you need to perform a test using these ID cards, considering the low associated risk, it might be possible to use the lot 50520.93.09 but with a particular attention to the interpretation of positive results:

By manual method, don't use the well 3 of the card.

• On the automates, if a positive result is obtained in the well 3, use the manual method following the instructions above.

Any negative result obtained with this lot would be perfectly valid.
