Safety measure relating to the RIWOmobil Product nos. 32116004, 32116005, 32116014 and 32116015

Identification of the affected medical devices:

Equipment Cart RIWOmobil product nos. 32116004, 32116005, 32116014 and 32116015. See enclosed list for affected series numbers.

Description of the problem:

Ladies and Gentlemen,

on the basis of a customer complaint, it has come to our notice that in two cases the power cable has been disconnected from the panel-mounted socket due to mechanical overload. This led to complete failure of the **RIWOmobil product no. 32116** equipment cart, as a result of the associated interruption of the power supply.

Measures to be taken by the addressees:

The product can continue to be used. However, we expressly draw your attention to the fact that until receipt and assembly of the new Mounting Kit for Power Cables Product no. 643301191 the correct plug connection for the power cable to the panel-mounted socket should be checked before the equipment cart is used.

We hereby draw your attention to the fact that we have revised our Instruction Manual in light of this information. An updated version will be sent to you together with the mounting kit. You should replace the existing manual with the revised Instruction Manual.

In order to comply with the requirement to have a record of verification for the receipt of this **Urgent Safety Information**, we require the enclosed response form, and we ask you to return this to us by fax to the **fax number +49 7043 351360** by **04.03.2014**.

The responsible national government agency (Federal Institute for Drugs and Medical Devices in Bonn) has been informed about this **Urgent Safety Information**.
