Dear Valued Customer,

Synthes GmbH is initiating a voluntary recall of all lots of the above mentioned article of Small Electric Drive (SED). The Small Electric Drive is designed for use in general traumatology, especially hand and foot applications involving surgical procedures such as drilling, burring, reaming, pin and wire placement, cutting of bone and hard tissue. Our records indicate that you may have inventory that is impacted by this recall.

Description of problem:

It has been reported that the Small Electric Drive (SED) may experience failure modes such as the device not functioning, the device operating solely in reverse mode, the device not operating in reverse when intended or an unintended start of the device.

Potential hazard:

If the device is tested in the operative theatre and the unit does not function, the user **most likely** would discontinue use of the affected part, and a replacement power tool would be procured, which may lead to surgical delay.

An unintended start of the hand piece or wrong mode/direction could cause bone/soft tissue damage, peripheral nerve damage and /or vascular damage because the hand piece has the potential to progress further into the surgical site when the operator is not intending this motion. These injuries may need surgical or medical intervention.

Alternative Product Options:

We are investigating the root cause of these malfunctions, however we do not currently have a definitive solution to address the issue. We understand that the recall of this device may have an impact on your surgical schedule; as such, DePuy Synthes Power Tools would like to propose options to assist you with a replacement for your Small Electric Drive Product (05.001.175).

Option 1: DePuy Synthes will provide you (at no charge) with a Colibri II (532.101), along with an electric adaptor (05.001.108) and a wire driver (532.022) to use instead of your Small Electric Drive.



Option 2: DePuy Synthes will provide to you (at no charge) a K-wire attachment for wires 0.6mm-1.6mm in diameter (05.001.037) to use with the Electric Pen Drive handpiece.
