Abbott Medical Optics Inc. (AMO) is voluntarily recalling a limited number of TECNIS iTec Preloaded Delivery System Lens, Model PCB00. AMO is initiating this action due to a potential manufacturing process non-conformance. There are 113 lenses potentially impacted by the non-conformance.

AMO has not received any reports of adverse events associated with the affected lenses. The non-conformance that occurred during the manufacture of these lenses does not indicate that there is a significant patient safety risk; however as a precautionary measure, AMO is retrieving any of the lenses that have not been implanted.

This recall only affects the specific TECNIS iTec Preloaded Delivery System Lenses with the serial numbers listed on page 3. No other AMO IOLs are affected by this recall action. TECNIS iTec Preloaded Delivery System lenses that have been implanted should not be recalled. Surgeons that have already implanted affected lenses are encouraged to track these patients, bring them back for a follow-up visit (if they have not done so) to review the patient's outcome. It is recommended that patients be observed for any signs of increased intraocular inflammation in the three months following IOL implantation.

Please take the following actions related to your inventory:

- 1. STOP using and remove from your inventory all affected TECNIS iTec Preloaded Delivery System lenses listed on Page 3.
