Due to an incident in the market we have discovered that at the weights we placed on the market, 400 gr. (Art. No. 32-302-10-01) and 800 gr. (Art. No. 32-302-12-01), for the Scherbak vaginal speculum fractures can occur in the laser welded seam between the holding hook and the weight involved.

It is our obligation to inform you of the risks to the user and patient that can arise when handling the relevant product from Gebrüder Martin GmbH & Co. KG due to detachment of the holding hook from the weights involved (Art. Nos. 32-302-10-01 and 32-302-12-01).

Please note that one of the affected Scherbak weights, 400 gr. (Art. No. 32-302-10-01), was also placed on the market in the full set we made available (Art. No. 32-302-00-01).
