Description of the problem:

Diagmed Healthcare Ltd has become aware that the GIS-10 OxyBloc device was not properly classified for marketing and distribution in the European Union. This represents an inaccuracy in the CE labeling. There have been no potential hazards identified and no associated risk to patients associated with use of the OxyBloc Bite Block device. The manufacturer requested all EU Distributors to quarantine all stock on 21 February 2014 and issued a follow up letter on 18 March 2014.

Instruction on action to be taken by the End User:

Our records show that you have taken delivery of the affected product since January 2011.

Please destroy any remaining stock that you have and notify Diagmed Healthcare of this action using the attached form. We can arrange for appropriate replacements to be sent upon receipt of this notice.
