

Urgent Field Safety Notice: QIAsymphony[®] DSP Virus/Pathogen Midi Kit (REF 937055), LOT 148028163

Dear customer,

Please note that we have identified an issue with QIAsymphony DSP Virus/Pathogen Midi Kit (REF 937055), LOT 148028163. According to our records, you have received a kit from this lot.

Some reagent cartridges (REAG CART) of this kit lot contain reagent troughs that are not filled correctly. This leads to a decreased quality in the resulting nucleic acids.

Detailed description

Some reagent cartridges (REAG CART) of this kit lot contain reagent troughs (5 and 6) that are not filled correctly with Buffer QSW2. As a consequence, the nucleic acids purified with affected reagent cartridges do not meet the expected quality due to contamination with inhibitory substances. The performance of the resulting nucleic acids in downstream applications is decreased.

If you have any remaining stocks of the affected QIAsymphony DSP Virus/Pathogen Midi Kit lot or the affected QIAsymphony DSP Virus/Pathogen reagent cartridge lot, please DO NOT use them.

If you have used the affected lot of QIAsymphony DSP Virus/Pathogen Kit, we recommend a review of the corresponding results of the downstream application.
