### Re: AXIOM Aristos FX systems; possible drop of the cable holder

Dear Customer.

This letter is to inform you of a possible hazard to patients or operators when moving ceiling suspension of all AXIOM Aristos FX systems (7414803) with serial numbers up to and including 1168.

#### When does this malfunction occur and what are the potential risks?

In case, the 3 wheeled cable cart moves behind the point of the fixed cable holder, the corrugated hose may get stuck behind the hose from the fixed cable holder (picture 1).

In case the cable cart and the corrugated hose cannot move freely, the cable cart may get pushed out of the ceiling suspension if pulled into the direction of the tube stand. If this occurs, there is a potential for the cable holder to drop down and hit patients or system operators.

### What steps can the user take to avoid the potential risk of this issue

Please ensure, that the corrugated hose does not get caught behind the hose from the fixed cable holder and that it can move freely (picture 2).

Special attention should be paid to avoid possible risk of injury to patients or operators.
