# **Urgent Field Safety Notice**

## Fast Nut for toilet raiser fixed Hi-LOO and toilet armrest Supporter

Dear valued customer,

With this Field Safety Notice, Etac provides information on important issues in relation to a Field Correction of Hi-Loo and Supporter. The Field Safety Notice is intended to ensure that all health facilities with influence of fixed Hi-Loo and Supporter users will receive important information on the background and execution of this Field Correction.

#### **Background:**

Etac has received information from a few users of malfunctions with the toilet raiser fixed Hi-Loo and toilet armrest Supporter. It is reported that the Fast Nuts fastening the toilet raiser and the toilet armrest to the toilet in some cases are loose. Etac is unaware that loose Fast Nuts would have resulted in any serious injuries. There is however a potential risk for harm and injury if the Fast Nuts loses and the toilet raiser or toilet armrest thus becomes unstable.

#### **Field correction:**

To prevent a potential situation of fixed Hi-Loo or Supporter coming loose, Etac is voluntarily issuing this Field Correction of all potentially affected toilet raisers and armrests. Hi-Loo, Supporter and accessories, delivered from Etac from December 12, 2014 until April 17, 2015 are within the scope of this Field correction. The Fast Nuts of the toilet raisers and toilet armrests shall be replaced to ensure a continuous long term safe use.

# You will be contacted by an Etac representative to arrange for this replacement of Fast Nuts to be performed.

The activities will start in April 2015 and carried out as soon as possible, at latest September 30, 2015.

There are no reasons for an immediate stop of using fixed Hi-Loo or Supporter. However, as an intermediate precautionary action awaiting the Fast Nuts replacement, user facilities are requested to be observant and inspect the fixed Hi-Loo and Supporter to see if there are visible signs of a Fast Nut coming loose.

Etac apologizes for any inconvenience and asks that this notice is passed on to all those who need to be aware within your organization, or to any organization where the potentially affected devices have been transferred. This notice should also be passed to end users concerned by the affected products.
