This notice is to inform you of an URGENT FIELD SAFETY CORRECTIVE ACTION that has been initiated by Biomet UK Ltd which involves the Exceed ABT Spring Loaded Impactor referenced above. Our records show that the instrument may have been distributed to your hospital as a single instrument and/or as part of the instrument set contained in kit number 31-600120.

The Exceed ABT Spring loaded impactor handle is an impaction device used for insertion of the Exceed ABT acetabular shell during Total Hip Replacement.

Biomet UK Ltd has initiated this action following certain complaints that the threaded central rod can break during acetabular shell insertion.

Biomet UK Ltd has been unable to replicate the reported breakage during investigation of these complaints; however Biomet UK Ltd is issuing this FIELD SAFETY NOTICE to make users aware of this potential issue and to highlight the importance of adhering to the relevant sections of the applicable surgical technique:

"Turn the strike plate clockwise to firmly tighten the spring loaded threaded tip in the shell apical hole. Hold the shell with the other hand whilst engaging the thread to prevent the shell from rotating.

IMPORTANT: It is advised to check that the threaded tip is always fully engaged in the cup apical hole when impacting. This helps minimise any risks of threaded tip damage."

Biomet are initiating a full replacement programme to replace the threaded rods with a design enhancement. You will be contacted by your market representative to arrange this replacement in the coming weeks. In the interim period, it is recommended that a visual inspection is performed to ensure thread is undamaged prior and post implantation of the cup.

In the remote event of a thread fracture occurring during surgery, care should be taken to remove any debris from the surgical site and apical hole of the shell where it is most likely to be retained.

What you need to do

- 1. Ensure all relevant Hospital staff are given relevant awareness training relating to this matter to ensure they are fully informed.
- To assist us with this action, please ensure that the operating staff are made aware of this matter without delay and that all the affected instruments are identified. Any damaged instruments should be withdrawn from use and a replacement threaded rod will be made available.
- Complete and return the attached "Response Form" to Biomet UK Ltd or to your local Biomet
 Distributor. This confirms the fact that you have received and understood the attached FIELD
 SAFETY Notice, informed relevant theatre staff and have physically checked all inventory and
 hospital locations.
- 4. If you identify any item from the affected item/ lot combination, you will need to indicate the quantity you have available for return, the items then need to be returned to Biomet UK Ltd or to your local Biomet Distributor as soon as possible, you must ensure you complete the attached Fax-Back response form and return it to Biomet UK Ltd or to your local Biomet Distributor as soon as possible.
