Dear Customer,

It has been brought to our attention an incident with serious clinical consequences following the involuntary fall of the footrest.

During the swing in position upright of the table, the footrest not having been fixed in the rules, this footrest is descended brutally until its mechanical stop, and this movement has surprised a mom who held her child.

This Field Safety Notice is intended to inform you about:

- · what the problem is and under what circumstances it can occur
- the actions that should be taken by the user in order to prevent risks for patients

#### **AFFECTED PRODUCTS**

#### **SAFIRE 17**

#### PROBLEM DESCRIPTION

At the time of the realization of an examination of the abdomen on a baby of 1 month, the table SAFIRE 17 was moved from position laid down towards the position upright. The footrest, not having been fixed normally and not being blocked on its position, is descended brutally until mechanical blocking in low position. This movement, involuntary, has surprised the mom who released her baby, involving a cranial traumatism with this newborn.

#### **HAZARD INVOLVED**

The fall unexpected of the footrest can surprise, to involve inopportune reactions, to wound by its weight the patient, or to involve the fall of a patient standing up on a footrest not fixed.

#### **AFFECTED PRODUCTS**

France has 47 units concerned with this alarm.

#### **ACTION TO BE TAKEN BY CUSTOMER**

Even when the footrest is not used as support, as at the time of the laid down position, please always block this last in its position. You have to ensure of the blocking of the footrest while following the operation manual, i.e. while trying to make slip the footrest fixed of before behind. If this last is normally fixed, displacement is impossible. If the footrest moves, start again the procedure of installation of the footrest according to the operation manual.

#### **ADDED DOCUMENT**

You will find in enclosures an extract of the operation manual of the SAFIRE indicating the procedure to be respected during the fixing of the footrest.
