
Details of affected devices & description of the problem:

BD Life Sciences – Preanalytical Systems is issuing this product advisory notice for the BD Vacutainer® EclipseTM SignalTM Blood Collection Needle with Integrated Holder (catalogue code 368835 and 368836). Through customer feedback, BD has become aware that some lots of the BD Vacutainer® EclipseTM SignalTM Blood Collection Needle with Integrated Holder have the potential for the integrated holder to become detached from the needle. This detachment can lead to possible sample collection failure and in exceptional circumstances have the potential to cause a needlestick injury.

This Field Safety Notice only affects the catalogue and lot numbers listed in the table in attachment 1. To locate the catalogue and lot numbers refer to attachment 2.

By following the advice below, impacted lots of the BD Vacutainer[®] EclipseTM SignalTM with Integrated Holder can continue to be used and distributed within your organisation.

- Prior to use, ensure that the pink Eclipse Shield is positioned over the green or black IV shield (as per picture below).
- Grasp the IV shield and the Eclipse Safety Shield together and the holder in the other hand and pressing firmly down on the Eclipse Safety Shield pull in a straight direction (as per picture below). Do not bend the device whilst pulling.
- If the holder becomes detached, dispose of the device in an appropriate sharps container.





Advice on action to be taken by Healthcare Professionals using the BD Vacutainer® EclipseTM SignalTM with Integrated Holder:

- Undertake an assessment within your healthcare establishment using the modified instructions for use and of the impacted lot numbers (attachment 1);
- If your assessment concludes that you wish to continue use of the impacted devices:
 - Inform appropriate personnel in your organisation of this Field Safety Notice and instructions for use:
 - Complete Option 1 on the acknowledgement form (page 4) and return as soon as possible or no later than the 1st September 2015.
- If your assessment concludes that you wish to return impacted lots to BD in exchange for a credit note:
 - Inform appropriate personnel in your organisation of this Field Safety Notice:
 - Complete Option 2 on the acknowledgement form (page 4) and return as soon as possible or no later than the 1st September 2015..

Please maintain awareness of this notice and resulting actions for an appropriate period to ensure effectiveness of the corrective action.








Attachment 2: Guidance on the location of Lot Number and Catalogue Number
