Return of the Medical Device to the manufacturer

**Date Issued:** 18<sup>th</sup> December 2015, 15:30 P.M.

### Audience

Hospital and clinic administrators, purchasing departments, distributors, pharmaceutical offices.

#### Product

Citra-Lock S 4% is a sterile Catheter lock solution, anti-clotting and antimicrobial prefilled syringe available in the market with the references 359, 3591S2 and 3592S.

## **Purpose**

To alert health care professionals and facilities to <u>stop using</u> all batches of Citra-Lock S 4% manufactured from January 2015 through December 2015 due to a still yet non identified suspicion of unknown foreign matter. The affected batches are as follows:

## Summary of problem and scope

Sterisets Medical Products is a contract manufacturer of medical devices used in Hospitals and Clinics, we produce sterile prefilled syringes with the outmost care and concern regarding quality in our products. We believe that our environmental





monitoring, cleaning procedures and the performance of sterility testing and endotoxin testing is a more than good enough rationale (since it is the GMP approved procedures) to exclude environmental contaminants.

# Advice on action to be taken by the user

The products have been manufactured by Sterisets Medical Products and sold to Dirinco B.V. only.

Sterisets Medical Products is responsible to initiate the return of the products (recall) and therefore requires the products to be placed in quarantine.

Dirinco B.V. assures that the products will be in quarantine at Dirinco's facilities, this includes all batches that have been distributed to his customers.

#### **Forward-Looking Statements**

Sterisets Medical Products expect to release forward-looking statements of our investigation that are based on hard evidence from our laboratory testing results that will allow us to conclude on this issue.

The Dutch Healthcare Inspectorate will be advised of this FSCA.
