Reason for Correction

Siemens Healthcare Diagnostics is issuing an Urgent Field Safety Notice for the buckets (Model 4464-R) (SMN 10723514: Hettich Centrifuge Bucket Kit) of the Hettich Rotanta 46 RSC Robotic and Rotanta 460 Robotic Centrifuges that are listed in Table 1.

Hettich, the centrifuge manufacturer is currently investigating the reason for premature bucket failures.

Risk to Health

When the Hettich Centrifuge bucket fails during centrifugation, the potential exists for a delay in patient testing and the potential for movement/rotation of the Centrifuge. The risk for user injury and/or for potential clinical impact due to a delay in testing is negligible.

Actions to be taken by the Customer

To avoid potential centrifuge failure and laboratory interruption, Siemens Healthcare Diagnostics is advising you to follow the instructions provided in the attached letter from Hettich.

Siemens Healthcare Diagnostics continues to strongly recommend that customers thoroughly follow the centrifuge maintenance instructions in the product operator manuals.

We assure you we are working closely with Hettich to achieve a long term solution.

Please review this letter with your Medical Director.

Please retain this letter with your laboratory records and if the system has been relocated please forward this letter to the appropriate current user facility.
