### **Description of issue:**

Kimal have received one customer complaint, that the product above has a discrepancy with the seal of the pouch. We have identified internally after inspecting retained samples that there may be some cases where the pouch has failed to seal at the peel corner, meaning the product is no longer sterile.

We kindly ask you to inspect your stock of the above mentioned product and lot number. Should you identify that the pouch is not sealed, remove from your inventory, and dispose of the affected product. Please inform Kimal on the quantity disposed of and free of charge, unaffected product will be provided to compensate. The photographs below show a defective seal and an acceptable seal:







Our records indicate that Kimal has shipped the abovementioned product to your facility as a Kimal finished product. Therefore we draw your attention to the following instructions:
