

Safety Notice - Product Recall

Product: Ennovate® Rod Persuader
Article-No.: SZ277R



Aesculap AG has received feedback from the market that the use of the SZ277R - Ennovate® Rod

Persuader can lead to the loosening of individual components. To be more precise, pins, which are located at the lower portion of the gold-coloured threaded spindle, may loosen inside the instrument. Internal investigations have shown that with the current design of the Rod Persuader, a recurrence of the above mentioned topic cannot be ruled out. So far, there is no case in which an intra-operative release of the pins has been observed.

As a precautionary measure, Aesculap AG has decided to recall the affected product from the market.




Figure 2: SZ251R tray - The Ennovate® Rod Persuader is stored in the lower layer of the tray.

1. SZ273R - Ennovate® Rod Pusher,

Tray SZ201R / Set no: SZ200- Ennovate® Set Open Implantation:

This instrument can be used in case of slight rod offsets.

2. SZ275R - Ennovate® Fork Rocker CVD,

TraySZ206R / Set no: SZ205- Ennovate® Open Connector Application:

This instrument can also be used for slight to medium rod offsets

3. SZ405R - Ennovate® FRI Downtube Short,

Trays SZ401R and SZ403R / Set no: SZ400 and SZ402 – Ennovate® Open MIS FRI:

This instrument can be used in the presence of slight to high rod offsets, for spondylolisthesis reduction (up to and including Meyerding Grade 2), and the reduction of fractures. All functionalities of the Ennovate® SZ277R Rod Persuader can thus be completely covered by this instrument.
