To whom it may concern,

B. Braun Medical Ltd has become aware that Vasofix Safety ported cannulas are being used with power injectors in many hospital Radiology Departments. This may, in some cases, result in fluid leakage at the injection port due to the silicon valve being unable to withstand exposure to the high pressures of a power injector.

We take this opportunity to highlight that the Vasofix Safety product group is suitable for use with pressure up to 3 bar. Use of these products with greater pressures is considered off-label use. The Instructions for Use for Vasofix Safety will be updated accordingly.

Please contact B. Braun to discuss suitable alternative products.


