Dear Sir or Madam,

Through the continuous monitoring of the products distributed by Mindray, we have become aware of one potential issue associated with the sterilizable handle assembly used in LED Surgical Light. This letter is intended to provide you with information as following:

#### Details on affected devices:

The affected products are the sterilizable handles assembly used in LED Surgical Light. The affected devices and how to identify the serial numbers are listed in appendix 1 *List* of *Affected devices*.

#### **Description of the problem:**

Mindray has identified a potential issue with the sterilizable handle assembly used in LED Surgical Light. Some of the material fitting size of the sterilizable handles assembly may not meet the company's internal control standards, which affects product reliability. In order to eliminate potential safety risk, Mindray will recall all affected products voluntarily.

To date, there are no reports of death or injury associated with this potential issue.
