Hazard giving rise to the FSCA	The device may not deliver 1000ppm of free chlorine during
	disinfection.
Probability of problem arising	It is highly unlikely that a product manufactured before February
	2019 would provide 1000ppm of free available chlorine after a
	10 month shelf life.
Background on issue	The products manufactured before February 2019 were labelled
	with a 18 month shelf life. Once our first real time stability
	completed it was suggested that the amount of free available
	chlorine was below 1000ppm between 10 and 12 months.
Other information relevant to	The various stability studies also confirmed that storage at high
the FSCA	temperatures >30°C would have a further negative impact on
	the shelf life of the product. This was highlighted on the product
	label.
