**For information to:** Customers who have received the products listed in **Appendix 2** to this notice.

**Problem description:**

We would like to kindly inform you about a possible problem with the sterility of the cardboard container that can be used as a carrier tray for sterile medical instruments/devices.

The component is included in the specified MATOSSET sets listed in **Appendix 2**.

The cardboard containers are intended for the reception of waste and/or as a collection container for smaller waste in the medical field for short-term use.

One of our suppliers of the cardboard containers has found cases of non sterile containers in sterilised sets which could have infected instruments and products.

**Potential hazards:** This problem may result in the use of a non sterile surgical set in the surgical area and the contamination of surgical equipment, potentially infecting patients.

**Recommended actions that the user should take:**

For safety reasons, we have decided to stop the production and withdraw the sets containing cardboard containers.

As of August 6, 2019, sets with cardboard containers are not manufactured and implemented on the market.

We kindly ask you to complete the attached form (**Appendix 1**) and send it to the address provided.

We apologise for the inconvenience caused by shortages in product deliveries and thank you for your understanding! We want to ensure you that patient safety is most important to our company.
