



Urgent field safety notice

Description of the problem

Customers using MRX Owren's PT reconstituted according to 1X-method have sometimes noted error messages from their instrument when analysing controls and patient samples, making it necessary to rerun samples to obtain a result. The problems are reported to be related to the occurrence of precipitation found in the reagent.

Patient impact

No incorrect results for patient samples have been reported. MRX Owren's PT is, however, used for Warfarin dosage and if the results are incorrect there is a risk that Warfarin is given in incorrect dosage, and MediRox therefore recommends caution.

Specification changes necessary to avoid future problems

To avoid precipitation, it is necessary to change the information in IFU regarding the specified stability for MRX Owren's PT reconstituted according to 1X-method, stored at 2-8°C, from 7 to 3 days.

For 1X-method reconstituted reagent stored at 15-25°C, 2X method reconstituted reagent stored at 2-8°C and 2X-method storage at 15-25°C specified stability remains unchanged.

Necessary actions to be taken by the user

According to IFU, controls shall be analysed regularly, and if control values are out of specification the reagent shall not be used for analysis of patient samples.

Use 1X-method reconstituted reagent stored at 2-8°C for a maximum 3 days after reconstitution.
