## Urgent: Field Safety Notice – COM21KLA.008 Batch KIT IRIS

Type of Action: Advisory

## Dear customer,

It has come to our attention that in Batch KIT IRIS a problem has been recognized. The problem concerns the missing of a Filter in the base of the needle for the Bulk vial and/or the waste vial.

It concerns:

Name: Batch KIT IRIS
Part-number: 0246050022

Batch number: Unknown at the time of writing this notification

Due to the missing filter the sterility of the Radiopharmaceutical in the bulk vial can be compromised.

We are working with our supply chain to have sufficient stock to replace all stock in the market, however, till then we advise you to check the presence of the filter before the use of the kit in 100% of the cases. To prevent unintended use of needles without the filter we sent you this notification with the request to check the 2 needle sets before using them in the IRIS. For selection you can use the below photos as reference:

## Batch KIT IRIS content:







In these needle assemblies we can see a white filter as below:

NOT GOOD and GOOD situation.






If you find any anomalies in your product, do not use that specific needle/kit.

As our needle supplier cannot say a definite failure ratio (although expected below 1%) we would like to hear from you as soon as possible any found rejected part (without the filters) to determine the impact and involved batches.

For this we kindly ask you to let us know the batch information as printed on the sterile packaging of the main kit. It concerns batches that were produced up to and including week 27-2021, which can be recognized by the first 4 digits of the batch number, for example 2721XXXXXX.

To have sufficient stock to replace the kits in the market we need to inventory all stock levels. To understand the stock situations at your facility, we kindly ask for your current stock level and expected/planned use in the coming months.
