Urgent Field Safety Notice Some code-batches of MONOMAX, MONOPLUS, MONOSYN, NOVOSYN, PREMICRON, PREMIPATCH & SAFIL Return of the Medical Device to the manufacturer Att. Users of above products

December 15th, 2021

Dear Sir or Madam,

B. Braun Surgical, S.A.U. is voluntarily recalling some reference/batches of Monomax®, MonoPlus®, Monosyn®, Novosyn®, PremiCron®, PremiPatch® and Safil®.

Monomax® is a sterile extra long-term absorbable monofilament surgical suture made from poly(4-ydroxybutyrate) (C4H6O2)n polymer. Monomax® absorbable sutures are indicated for use in general soft tissue approximation when extended wound support is needed (more than 3 months) in abdominal fascial closure. Not for use in cardiovascular or neurological tissues, microsurgery, ophthalmic surgery, as well as for use in tissues in contact to acidic body fluids.

MonoPlus® is a sterile synthetic absorbable monofilament surgical suture made from the homopolymer polyp-dioxanone. MonoPlus® is indicated for use in general soft tissue approximation, especially in cases where an extended wound support of more than 4 weeks is desirable. MonoPlus® can also be used in the paediatric cardiovascular surgery. In vascular surgery, MonoPlus® is indicated for the suturing of autologous peripheral vessels.

Monosyn® is a sterile synthetic absorbable monofilament surgical suture produced from a copolymer of 72% glycolide, 14% ϵ -Caprolactone, 14% Trimethylenecarbonate. Monosyn® is indicated for use in general soft tissue approximation and/or ligation but not for use in cardiovascular or neurological surgery. Typical applications are subcutaneous and intracutaneous sutures, closing of episiotomy, gastro-intestinal anastomosis.

Novosyn® is a sterile, absorbable surgical suture material produced from a copolymer composed of 90% glycolide and 10% L-lactide. Novosyn® is indicated for soft tissue approximation and/or ligation in general surgery, when surgical practice requires the use of synthetic, absorbable, braided suture material. Novosyn® sutures are also for use particularly in gynaecology and urology. Novosyn® is also indicated for ophthalmology and for microsurgery if an absorbable suture material is preferred.

PremiCron® is a sterile non-absorbable synthetic suture composed of polyester yarns made of polyethylene terephthalate (PET). PremiCron® is intended for use in soft tissue approximation of the wound edges to render possible an undisturbed wound healing. PremiCron® is indicated for use in general surgery, cardiovascular and vascular indications and reconstructive and plastic surgery, when surgical practice requires the use of a non-absorbable suture material.

PremiPatch® PTFE pledgets are pre-cut sections of nonabsorbable, undyed PTFE polytetrafluoroethylene), available in various sizes, two shapes (oval and rectangular), two felt types (firm, soft), either pre-pierced or

blind. PremiPatch® PTFE pledgets are intended to be used to mechanically reinforce fragile tissues or prostheses and prevent them from being torn or cut by the suture. PremiPatch® PTFE pledgets are indicated in cardiovascular surgery (e.g. valve replacement, cardiac injuries, ventricular septal defects), when a in combination with a non-absorbable suture.

Safil® is a sterile, absorbable surgical suture material produced from polyglycolic acid. Safil® is indicated for applications where surgical practice requires the use of synthetic, absorbable, braided suture materials, particularly in the region of the gastro-intestinal tract, in gynaecology and urology and for subcutaneous sutures and ligatures. Safil® is also indicated for ophthalmology (e.g. strabismus operation) and for microsurgery (e.g. peripheral nerve anastomosis and still growing tissues) if an absorbable suture material is preferred.

Description of the medical device deficiency

From an internal nonconformity, the company detected that some units of the mentioned products could have the secondary package open, as a consequence the product sterility is compromised.

Potential harms associated

If second pack is broken and/or opened, it could lead to infection, wound dehiscence, sepsis leading a life-threatening injury, risk of potential reintervention, need of medical treatment.

In those patients that the device has already been used, no additional follow-up is required, if the patient presents any of the complications described, the hospital protocol for such situations will be acted upon accordingly.

Actions to be taken

Please identify and guarantine if you still have the listed product in your warehouse.

Please check with your customers if they still have the listed product in their warehouse. If yes, ask them to send the product back to you immediately.

Once you have all affected units for return contact us for the management of the material.

Please, fill out the attached "FSCA/Recall Confirmation Form" and send the completed form to us by January 15th, 2022.

This notice needs to be passed on all those who need to be aware within your organization and to any organization where the potentially affected devices have been transferred.
