Urgent FIELD SAFETY NOTICE - Perfusor Space

Dear Sir or Madam,

We, the B. Braun Melsungen AG, have decided to execute additional control-procedures on a limited set of Perfusor Space pumps in the context of a Field Safety Corrective Action.

Our distribution data indicate that you received one or more of the affected pumps as referenced in the APPENDIX.

Reason for the Field Safety Corrective Action

There is <u>evidence_indication</u> that <u>one individual may not have conducted</u> certain steps in the final inspection of defined Perfusor Space Pumps. <u>were not conducted by a single person</u>. We therefore cannot exclude the risk that potentially non-conforming pumps have left the manufacturing and went into clinical use.

The risk can be allocated to a limited set of serial numbers of pumps manufactured between Jul-2021 and Dec-2021. Up to now, no harm or any other adverse patient outcome, which could be associated to the above described failure, has been reported to the B. Braun Melsungen AG.

Actions to be taken

We kindly ask you to initiate the following activities immediately and with priority:

- Review this Field Safety Notice in its entirety and ensure that all users of potentially affected
 product serial numbers (see annex) in your organization and other concerned persons are
 informed about this Field Safety Notice.
- If you are a distributor, please forward this correction notification to your customer.
- Identify and quarantine the affected devices.
