Dear Customer,

Betatex spa has undertaken a voluntary field safety corrective action recall for the M-CONNECT product codes, and kits containing such products, shown in Annex A.

Description of the problem and immediate action required

Betatex has received a number of reports about the possibility of the M-Connect hose coming loose from the fittings while in use.

This can have a negative impact on room hygiene as liquids passing through the M-Connect, which should be directed towards the collection bag, fall into the surrounding area. If the device is used for chest drainage, the detachment of the tube, if it is left open for a long time, could cause air entrance into the drainage tube, which could lead to pneumothorax.

There are currently no reports of patient complications.

Action to be taken by the customer

Stop using these products immediately. Check your stocks, complete and return the form provided. Return all involved and unused devices to Betatex spa.

Betatex has informed all customers and distributors of this field safety corrective action.
