Recall concerning

With this letter we would like to inform you about a recall of our product GUS-42-18-022 EBUS TBNA Ultrasound Needle System and ask you to take note:

Description of the problem:

We have been informed of a qualitative problem with the above-mentioned product, so that unrestricted, safe treatment of the patient can no longer be guaranteed.

Although the investigation results so far do not show a clear cause, we are conducting a precautionary recall for the potentially affected batches.



Patient risk & recommendation for further action:

The safety and performance of the product cannot be fully guaranteed. Based on the current state of knowledge, we advise against its use.

What measures are to be taken by the addressee?

Upon tracing, we have determined that you have received affected products. For this reason, we ask you for the following support:

- 1. please check if you still have products in stock from the above batch numbers (LOT).
- 2. Set the use of all affected lot numbers (LOT) in your possession.
- 3. Separate the batch numbers concerned (LOT) to avoid unauthorized access
- **4.** forward this **"Urgent Safety Information"** to all persons in your institution who need to be informed. If you have passed on the product, please identify the facilities/departments concerned and forward this notification to them immediately.

Please keep this information at least until the measure has been completed. The Federal Institute for Drugs and Medical Devices has received a copy of this **"Urgent Safety Information"**.

5. Please complete the attached **reply form** and return it by fax or email **immediately, but no later than 2022-03-31**, to be able to offer you an alternative as quickly as possible or to coordinate the return shipment of the affected items.
