Dear Risk Manager/Healthcare Professional:

The purpose of this letter is to advise you that Medtronic is initiating a recall of the SmartPill[™] SmartBar - model number FGS-0505. This field action only impacts the SmartBar and not other products in the SmartPill[™] family.

Issue Description:

The SmartPill[™] SmartBar - model number FGS-0505 has the potential to be contaminated with tobacco beetles. This contamination may lead to patient nausea, emotional changes, or a delay in the procedure which could lead to a delay in diagnosis.

Through January 25, 2023, Medtronic has received eight complaints related to this issue. No reports of injury have been reported.

There are no additional actions required for patients where a SmartPill™ SmartBar was used during a procedure. These patients should continue to be monitored in accordance with your medical facility's standard care protocols.
