ArcRoyal has been informed of an Advisory Field Safety Notice for Mediplast Suction set. Mediplast has noted a variation in the strength of the attachment between the hand piece and the suction tip. ArcRoyal place this Suction Set into Vingmed CPT DV5125 that may be in your inventory.

Details:

Mediplast has noted a variation in the strength of the attachment between the hand piece and the suction tip. No serious incident has occurred, but Mediplast is choosing to provide information about this, as low strength in the attachment between the hand piece and the suction tip could cause these to separate from each other. ArcRoyal therefore wish to provide notice that, in relation to the suction set contained in the lots of DV5125 listed below; there may be an increased risk of the suction tip separating from the actual hand piece attachment
