**Dear Valued Customer,**

DePuy Ireland U.C. has initiated a field safety action (removal) of three (3) lots of CEMVAC Revision Nozzles listed in the table above. The CEMVAC Revision Nozzles are designed as an optional extension nozzle to be used with the CEMVAC Bone Cement System. These nozzles are designed to assist in the placement of bone cement into a long and/or narrow intermedullary canal.

Our records show that you, or your facility, received one or more units of the product lots listed above. Please carefully review this notice for the steps that you should take to respond to this field safety action (removal).

**Reason for the Field Safety Notice (Removal):**

Three (3) lots of CEMVAC Revision Nozzles are being removed because they were distributed prior to being sterilized.

**Potential Patient Impact:**

Use of the unsterile nozzle may result in infection, although it is expected that contamination on the device is low as a result of other cleaning processes. Health care providers who have used the subject products on patients should continue to follow those patients pursuant to their standard of care for those procedures.

To date, we have received no complaints related to this issue.

**Please Take the Following Steps:**

1. Examine your inventory immediately to determine if you have the subject products and quarantine them immediately. **DO NOT USE THE SUBJECT PRODUCTS.**
