The aim of this communication is to inform you about calibration issues with VIDAS® DENGUE NS1 AG 60T (Ref. 423077) lot 1009977620 due to S1 value out-of-range high.

#### **Required actions**

In this context, we request you to take the following actions. Please:

- Stop using and destroy the impacted lot 1009977620.
- Distribute this information to all appropriate personnel in your laboratory, retain a copy in your files, and forward this information to all parties that may use this product, including others to whom you may have transferred our product.
- Complete the Acknowledgement Form in Attachment A and return it to bioMérieux to confirm receipt of this notice. It is important that you return the acknowledgement form to bioMérieux even if you determine that this urgent product safety notice does not impact your facility.

#### **Description of the issue**

bioMérieux received complaints from the field for invalid calibration with VIDAS<sup>®</sup> DENGUE NS1 AG 60T (Ref. 423077) lot 1009977620 due to S1 value out-of-range high and confirmed the product issue on this batch in our complaints laboratory.

An investigation is in progress to identify the root cause of invalid calibration on the lot 1009977620.

To date, the issue was not confirmed on other lots of VIDAS<sup>®</sup> DENGUE NS1 AG 60T (Ref. 423077) available on the market, and the evolution of the calibration of all VIDAS<sup>®</sup> DENGUE NS1 AG 60T (Ref. 423077) lots available on the field will be closely monitored until the root cause is identified.

#### **Impact to Patients**

Invalid calibration due to S1 out of range too high is associated with a risk of delayed patient results.

The risk of false results was excluded, the serologic interpretation is not impacted by the evolution of the calibration. The calibration would be out of range before the result of the assay is misinterpreted.
