The purpose of this Field Safety Notice is to advise you that FUJIFILM Irvine Scientific, Inc. is voluntarily recalling ISolate lot 0000020693 (the "Product" or the "Kit").


Reason for the Voluntary Recall:

The FISI Product is a sperm separation Kit which is intended for the separation of the motile fraction of sperm from seminal fluid for assisted reproductive procedures that involve the manipulation of human sperm. The Kit contains two components: the Upper and the Lower Layer components. According to the certificate of analysis ("COA"), the Product should contain Isolate Upper Layer Lot 0000020682 and ISolate Lower Layer Lot 0000020686.





FUJIFILM Irvine Scientific received one (1) report where the lot number of the <u>Lower</u> Layer component within the Product did not match the lot number on the COA. Instead of containing Isolate Lower Layer with Lot number **0000020686** with a shelf life of **31 December 2024** it was reported that the Kit incorrectly contained ISolate Lower Layer with Lot number **9925811106** and a shelf life of **30 November 2023**, as illustrated below:



Our investigations indicate only some kits of the Product contain the incorrect Lower Layer lot number. While both Lower Layer lots listed above met all final Product release specification, only Lot 0000020686 should be within the Kit per the COA.

Risk to Health:

Our investigations conclude that the potential incorrect lot number of ISolate Lower Layer within the Kit will <u>not</u> result in a risk to patient health. However, ISolate Lower Layer Lot 9925811106, which was incorrectly found in the Kit, will expire on **30 November 2023**, earlier than ISolate Lower Layer Lot 0000020686 which has an expiration date of 31 December 2024. Therefore, it is important that users confirm the ISolate Lower Layer Lot number within the Kit they received.

Actions to be taken by you:

If you have any of the ISolate, Lot 0000020693 at your facility, we request that you:





- 1. Immediately confirm the lot number of the ISolate Lower Layer, catalog #99258, contained in the kit at your facility (Lot 0000020686 being the correct lot number).
- 2. If the ISolate Lower Layer lot number is incorrect per the COA (not with lot number 0000020686), please stop using the FISI Product, return/destroy it, and request a replacement or credit for the FISI Product amount.

Note: As stated above, in the event that the incorrect lot number of ISolate Lower Layer was already utilized or is being utilized as of the date of this notification, there are no anticipated performance issues or risk to patient health.

- 3. Please complete and return the enclosed Field Safety Notice Customer Reply Form.

We will provide credit for this Product or replacement Product promptly. In addition, we want to let you know that the national Competent (Regulatory) Authority of your country has been informed about this communication to our customers.
