

URGENT: FIELD SAFETY NOTICE

CADD™ Medication Cassette Reservoirs

28 August 2025

Dear Valued Customers:

ICU Medical is issuing this letter to notify you of a potential issue with specific models and lots of 50mL and 100mL CADD Medication Cassette Reservoirs. This letter details the potential issue, the affected models and lots, and the required steps to perform.

Issue:

Certain CADD 50mL and 100mL Medication Cassette Reservoirs may exhibit weakened medication bag welds along the bag perimeter inside the plastic housing. This could result in medication leakage along the bag perimeter.

Potential Risk:

Leakage from a weakened medication bag weld could potentially result in delay or interruption of therapy, under delivery of medication, exposure to infectious or toxic agents, or air embolus.

No serious injuries or deaths have been reported to ICU Medical as a result of this issue.

Affected Models:

Out of an abundance of caution, CADD Medication Cassette Reservoir lots listed in the table below, are considered potentially affected by this issue and in scope of this notification. All customers to whom ICU Medical distributed these products will receive a copy of this notification

- 1. Review your inventory of CADD Medication Cassette Reservoirs to confirm if any of the lots listed in table 1 are within your possession.
- 2. Quarantine the affected product and destroy or discard it immediately following your institution's process for destruction or discarding.
- 3. Complete and return the attached Customer Response Form to EMEA-FSN@icumed.com within 10 days of receipt to acknowledge your understanding of this notification.
- 4. **DISTRIBUTORS:** If you have distributed potentially affected products to your customers, please immediately forward this notice to them and request that they complete the response form and return it to **YOU**. Then the **DISTRIBUTOR** must complete a <u>SINGLE form</u> with the required details and return to <u>EMEA-FSN@icumed.com</u>
