
This letter is to inform you of a Field Safety Notice regarding Human Care AB Altair Lifting Solutions. There was a potential risk of fall incident if the latest user manual was not followed, regular inspections were not conducted, and the belt was not replaced as recommended. Under extreme conditions of not following the above while heavily continuing to operate the lift, the lifting belt could come loose from the ceiling mount in the event of the of the belt stitching becoming outworn. Therefore, as an additional safety measure to the existing ones, Human Care AB will implement the belt clip in production of the device.

For devices already in use, the manufacturer will provide a belt clip where a potential risk is identified.

Issue Description:

Human Care have been informed of a fall incident caused by the failure to replace the belt annually as recommended in our inspection protocol and user manual. This incident highlights the vital importance of adhering to Human Care's recommended maintenance schedule to ensure both safety and optimal performance. To further enhance safety of the lifting device, a safety belt clip will be installed; this clip will prevent the wearing out of the lifting strap seam and consequently reduce the risk of the belt coming loose.

Recommended Mitigations:

- As an additional safety measure, Human Care will implement the belt clip in the next production of the device. For devices already in use, the manufacturer will provide a belt clip where a potential risk is identified.


The affected units include Altair Lifting Solutions manufactured between January 2021 and September 2025.
