"Latest news" presented by the Danish Medicines Agency

Anne-Marie Vangsted briefed the members on the book "Piller og Baciller" a Danish children's book targeting children and their parents obtainable from the Danish Medicines Agency. Anne-Marie Vangsted informed the Network that presently the Danish Medicines Agency had submitted a number of Danish executive orders for consultation at Høringsportalen, a Danish consultation portal, and that comments could be sent to the Danish Medicines Agency.

Information about medicine consumption, Helle Johansen, the Danish Medicines Agency's department of Statistics & Analysis (see presentation in Danish only)

Following a presentation of the area, it was discussed that the doctor's authorisation ID is sometimes missing on the prescriptions, which results in inappropriate registration of medicines prescribed. Annemarie Hellebek encouraged the Agency to draw up a couple of transparancies/slides to motivate prescribers to write their authorisation ID on prescriptions, the idea being for Kim Dalhoff and Annemarie Hellebek to include the slides in their teaching programme for new doctors.

Experience with ethnic minorities and medication, Lene Lauridsen, Odense Sct. Hans Pharmacy (see presentation in Danish only)

Lene Lauridsen encouraged the Danish Medicines Agency to prepare teaching material (e.g. short videos) on the internet in foreign languages about medicine – including contact with the Danish health sector, rules on generic substitution and reimbursement. The Danish Medicines Agency's patient safety competence team has subsequently forwarded this proposal to the Communications Department of the Danish Medicines Agency.

Briefing on pharmaceutical-related intoxication, Kim Dalhoff, Danish Poison Control Hotline (see presentation in Danish only)

It was discussed that children's dosages for paracetamol-products could possibly be made clearer. Kim Dalhoff assessed that it is often the parents who administer an incorrect dose. Pharmacies also report that it occurs that the one parent administers the dose first, and then the other parent also gives the medicine, thus resulting in overdosage. Abuse of methylphenidate in adolescents was discussed, and cooperation between the Danish Poison Control Hotline and the Danish Medicines Agency's Consumer Safety Division has been established.

Latest news from the High-Risk Medicines Working Group

Annemarie Hellebek told the Network that the people behind the Working Group have commented on the draft report. The concept of "high-risk medicines" was discussed.
