<Product name> 5 mg and 10 mg film-coated tablets is authorised for treatment of hypertension, treatment of stable chronic angina pectoris and treatment of stable chronic heart failure with reduced systolic left ventricular function in addition to ACE inhibitors, and diuretics, and optionally cardiac glycosides (see SmPC for the full indication). It contains bisoprolol as the active substance and it is given orally.

Measures to minimise the risks identified for medicinal products can be:
