Summary of Risk Management Plan for MIRABEGRON TEVA (MIRABEGRON)

This is a summary of the risk management plan (RMP) for Mirabegron Teva (MIRABEGRON) (hereinafter referred to as Mirabegron). The RMP details important risks of Mirabegron, how these risks can be minimised, and how more information will be obtained about Mirabegron's risks and uncertainties (missing information).

Mirabegron's summary of product characteristics (SmPC) and its package leaflet give essential information to healthcare professionals and patients on how Mirabegron should be used.

Important new concerns or changes to the current ones will be included in updates of Mirabegron's RMP.

Mirabegron is authorised for overactive bladder in adults and neurogenic detrusor overactivity in the paediatric population (see SmPC for the full indication). It contains Mirabegron as the active substance and it is given orally.

- Important advice on the medicine's packaging;
- The authorised pack size — the amount of medicine in a pack is chosen so to ensure that the medicine is used correctly;
- The medicine's legal status — the way a medicine is supplied to the patient (e.g. with or without prescription) can help to minimise its risks.

Together, these measures constitute *routine risk minimisation* measures.

In addition to these measures, information about adverse reactions is collected continuously and regularly analysed, so that immediate action can be taken as necessary. These measures constitute *routine pharmacovigilance activities*.
