This is to inform you of a product recall involving the Sonosite L25 Needle Guide Bracket which was sold within the product reference numbers identified below:

Dear Valued Customer,

CIVCO has recently discovered an interaction issue with the L25 bracket and needle guide. You are being notified, as your facility has been identified as having received an L25 bracket from the affected manufacturing lots. The affected brackets were manufactured and included in the kits identified and manufactured between 03/2003 through 09/2018.

Description of the Problem:

During the attachment of the needle guide to the bracket over a cover, the interaction of the needle guide and bracket snapping together can cause a puncture or tear in the cover. Breaching the cover provides the risk of cross contamination of the reusable ultrasound transducer as well as the patient. This could lead to serious injury as it is not know what contamination could be carried forward.

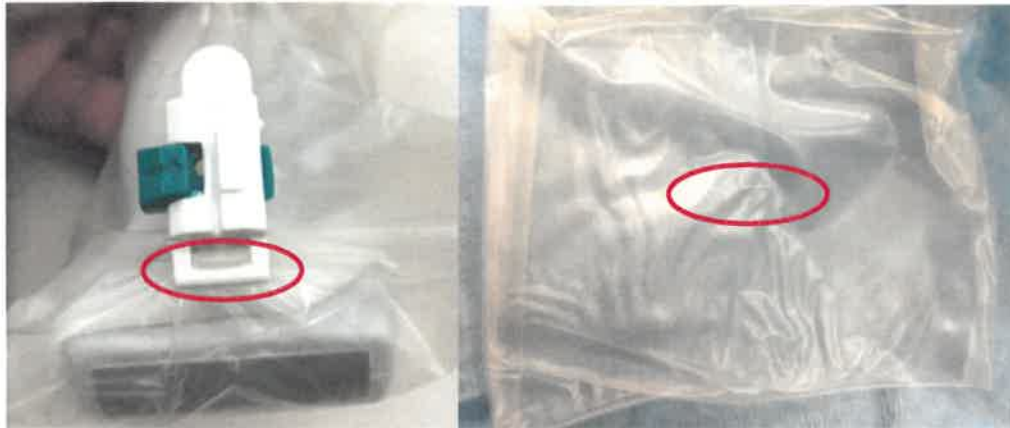


Fig 1. Assembled

Action to be Taken by the Customer:

CIVCO requests return of all L25 brackets which you may have. The reusable bracket may still be in your inventory. You can reference the manufacturing date located on the product label and return any manufactured between 2003.03 and 2018.09 for replacement. (see example below for manufacture date location)
